**Explanation of Responses:**

- This option vests over a four-year period, with 25% of the shares subject to the option vesting on the first anniversary of the grant date of April 15, 2022, and the remaining 75% of the shares subject to the option vesting over the subsequent three-year period in substantially equal monthly installments at a rate of 1/48th of the total shares subject to the option each month, subject to the Reporting Person's continuous service as of each vesting date.
- This option vests over a three-year period, with 1/36th of the shares subject to the option vesting in substantially equal monthly installments measured from one month following the grant date of February 1, 2023, subject to the Reporting Person's continuous service as of each vesting date.
- This option vests over a three-year period, with 1/36th of the shares subject to the option vesting in substantially equal monthly installments measured from one month following the grant date of January 12, 2024, subject to the Reporting Person's continuous service as of each vesting date.
